

Planning, Scoping and Policy


The scope of the report is commonly defined and determined by management. The scope typically consists of financial controls, operational controls and the General IT Controls of the organisation. Based on this scope, policies are developed for risk management, information security and quality management, which form the basis for the analysis of risks and design of the risk management framework.

Risk Framework

Analysis and Design

To design the risk management framework, templates, illustrations and guidelines are provided. The templates are based on *best practices* and are in accordance with either the COSO Framework, ISO 31000 or CoBiT guidelines. *Best practices* are based on the ControlReports database which includes industries' *best practices* and in depth knowledge of industries best risk advisors.


Implementation, Readiness and Completion

The prepared controle framework forms the basis for the implementation of individual controls and monitoring of the Control Framework in an organisation. Risklane provides additional services for readiness assessments to identify possible issues prior to the audit phase. After the processing of any findings as a result of the readiness assessment in ControlReports, the final draft is prepared for the external audit.

Step-by-step Guidance



Planning and scope

A compliance and risk management project team typically consists of an executive, project manager and project owner. Resources are planned, milestones are identified and communicated to all team members. In ControlReports a questionnaire is included to define and describe the scope of the risk control- or compliance framework.

Policies

ControlReports provides guidelines with detailed requirements for company policies. A company policy typically includes definitions, objectives and scope of the management framework. The policy is the basis of the management framework and includes roles and responsibilities of management and officers involved with risk management and compliance.

03

Risk Analysis

Events that endanger corporate objectives are identified including the impact and probability of these events. ControlReports provides a *step-by-step* approach to identify internal operational risks and external risks. Based on the resulting risk analysis, management determines the risk attitude per risk or risk category.

Design

The elements of the control framework are based on the requirements of the standard. The ControlReports templates for the design of individual controls are based on guidelines of the International Federation of Accountants (IFAC), ISO guidelines and industries best practices. ControlReports provides illustrative examples and explanations of the requirements of standards to draft the control framework and describe individual controls.

Implementation

The designed framework is adjusted to risks identified in the risk analysis and implemented in the organisation. The control framework typically includes a set of monitoring controls, application controls and General IT Controls, depending on the type of organisation and scope of the management framework...

Readiness assessment

The effectiveness of the implementation is investigated in a *readiness assessment*. An independent internal officer or Risklane expert reviews the draft management framework/report provided by ControlReports and performs audits to identify possible issues prior to the final assurance audit or certification audit.



07

Completion

The effectiveness of the design of the framework, existence, auditability and operational effectiveness were tested during diligent audit procedures. Identified issues are reported to management and are followed up by redressing procedures. Adjusted policies, procedures and controls are processed in ControlReports, resulting in a final draft of required documentation and the Control Report. You are then in control and compliant with the highest professional standards!
